- 5. When to Send Out Information to Members & Students about Book Club & Movie Discussions for Social Work Month: Elaine stated she found some discussion questions

 For the book and will send several of them to each of us to review. She stated she hasn't found any questions for the film yet. She said she will talk with Katie Huntington about sending the information out to members & students once we have discussion questions together.
- 6. Future CEU Presentations for Fall 2024 & Spring 2025: Cheryl M. asked why the Chapter nixed the Transgender Conference we wanted to have in the Fall 2024. Elaine stated she was advised the topic was too broad and they don't have enough staff to support the technical logistics such as break out rooms. Also, they were concerned we would not make enough money. She stated Amelia Lochner Malave, Interim Executive Director will be going on maternity leave. Jesse stated why couldn't we turn the transgender issue into a CEU presentation. Elaine stated we could and that was a good idea. The group spent some time brainstorming other potential topics. Jesse suggested forensic mental health-new approaches, treatments, interaction with treatment courts i.e. mental health court, Veterans court, drug court. Cheryl M. suggested looking at the Erie County Department of Mental Health for information. Jesse stated she would look at their website.

Sylvia suggested effects of AI on the Social Work profession-assessments. Cheryl E. stated Better Help has some simple AI linking individuals to mental health providers. Elaine stated that some faculty at UB School of Social Work are interested in technology including Nancy Smyth and a married couple by the last name of Sage and perhaps they might have some resources, ideas or interest in presenting on this topic. Sylvia to follow-up on this. Jesse suggested voting rights as a possible topic. She stated peoples' anxiety level is High and people have lost their lives during the Civil Rights Movement and feels voter Rights are eroding now. Jesse stated the Social Work profession is to help empower People and our Code of Ethics supports this. Elaine stated she has no idea who to reach out to on this topic. Sylvia stated the League of Women Voters educates people on Voting and she is a member. Jesse stated Pat Maxon, a member of the Retired Social Workers Special Interest Group might be a good person to reach out to and will follow-up In contacting her.

Elaine stated she knows a couple of people who might be willing to do some CEU Presentations. One is Steve Halady, who has an MSW & PhD in Philosophy and she Attended a presentation he did on mental illness. Also, Kerry Casey has done a Presentation on trauma and supervision. Elaine encouraged us to keep thinking of topic Ideas.
